### AUCTION PURCHASE POLICIES

The Captain Morgan Boats Boat Auction is open to dealers and the general public. All dealers and individuals must be registered before buying or selling vessels. Everyone must obtain a bidders number before bidding at auction.

All deals initiated on auction property must pass through the auction office, including those made before or after a vessel has crossed the auction block.

All vessels are sold "AS IS" without warranty or guarantee of any kind, regardless of any statements made otherwise.

**Full payment is due on the day of the sale** by cash or certified check. We accept Mastercard, Visa, American Express and Discovery. **Cash discount.** Documentation fee of 3% on other transactions. No ATM cards.

Vessels must be removed within 15 days or a \$5.00 per day storage fee will be assessed. Vessels left on the lot over 45 days will be sold as abandoned vessels.

**It is the responsibility of the buyer to examine the vessel before bidding.** The auction makes no warranties, implied or expressed. Once you have successfully bid on a vessel you are responsible for payment.

**Auction buyer and processing fees will be charged on each sale. Copies of the fee schedule are posted around the property and available at the registration table.**

**The auction is not a party to the contract of sale, which is between the buyer and the seller.**

**The auction reserves the right to refuse service to anyone.**

**Individual buyers must pay sales tax at the point of purchase. Sales tax in Hall County is 7%**

**Anyone caught dealing on the outside will be considered stealing and will be barred from the auction premises immediately.**

Good boats bring good prices. I will provide clean-up services if needed with early registration prior to March 25th.

You may bring your boat to the auction facility at Captain Morgan Boats in Flowery Branch by March 25th, so buyers have time to inspect your boat. If you have maintenance records, please include the information for the buyers.

The Captain Morgan Boats boat auction is open to dealers and the general public. **All dealers and individuals must register their vessels before the auction. It is the responsibility of the seller to provide clear conveyance of the vessel at the time of sale. This includes current registration for the boat and trailer title and registration. Please bring all registration papers to the sale.**

The seller agrees to pay all fees associated with the sale of their vessel. See the fee sheet for details.

State license regulations require that all funds received from buyers must be deposited into an escrow account, then dispersed by check within three (3) business days via registered mail. All fees will be deducted from the sale price of the vessel at auction.
